

FREEDOM *ALLIANCE*

How we will save Australia

Freedom Alliance is an idea born in the hearts of many; it is the expression and outworking of our collective consciousness, drawing us all toward the ultimate conclusion we know deep within ourselves to be the only way we can restore freedom and justice. It is a banner raised high, a rallying call to action, a coming together of the like-minded in trust, unity, strength and fierce resistance to a common foe. **Freedom Alliance** will become a bright shining light, a beacon of hope to all who are oppressed; it shall be our answer to the enemy's scheming against us to "divide and conquer"!

The days of division must come to an end now if we are to have any chance at restoring Australia to greatness as a land of peace and prosperity, of supreme justice and freedom. We must take a stand together as one, unified and resolved to expose the deeds of our common enemy, to shed light upon the corruption and deceitfulness that has come to characterise Canberra, too long the stronghold of the duopoly known as the Labor/Liberal cartel.

Make no mistake about this, we have an enemy well entrenched, armed with the weaponry of mainstream media, and backed by forces beyond these shores collectively known as the New World Order, comprised of its many divisions such as the U.N., the World Bank and IMF, the Council on Foreign Relations, the Fabian Socialists, the Bilderbergers and many other groups as you know, all intent on establishing an unelected, dictatorial global government that does not have our best interests at heart.

Our freedoms are being stripped away; our rights are being trampled on. Our constitution, the Bill of Rights, Common Law, once the hedge of protection against tyranny and injustice, has been under sustained attack from this illegitimate government intent on destroying what remains of our country as they sell us out to foreign powers, banks and other globalist organisations. Many have put up a gallant effort to prevent this onslaught, but we all continue to fail (defined as such because the situation is deteriorating rapidly). We fail because we do not stand together, we fail because as separate entities we are weak, we cannot be heard, and we are not organised.

Freedom Alliance is a coalition, a merger of all who care for the future of freedom into one united, powerful and effective federal political party that will have the potential to rival the "big government" party split into its two divisions known as the Liberal and Labor parties, and now more recently the subdivision known as the Greens. It is futile having so many fractured and divided organisations all vying against one another for attention, for support, for funding, for VOTES, especially when we all agree on the most important and fundamental issues that are at the core of what we are all standing for.

To this cause, we now have in principle support for this concept from the leaders of several minor political parties (the Australian Sovereignty Party, the F.R.E.E. Australia Party, One Nation, the Climate Sceptics Party, possibly the 'Shooters and Fishers Party' and Australia First Party, and now even the Democratic Labour Party). Beyond these political parties, we have many other organisations (such as U.P.M.A.R.T. and Aussie Speeding Fines) whose members are willing to join the **Freedom Alliance**, bolstering our unified position to heights we could only have dreamed of.

So, I shall now detail the operational mechanics of **Freedom Alliance**, and outline a first draft of our core policies and principles based on the many discussions I have had with the leaders of all the above listed organisations, policies that we can all agree upon and which are fundamental to our campaign to restore freedom and justice. I write this letter, and these policies, and formulate this strategy not as an individual concerned with my own personal beliefs or that of my own organisation, but I write this as a vessel, a conduit through which is channelled the ideas and expressions of many, agreeing to aside our petty differences and come together as one for the good of all.

Freedom Alliance shall be comprised of many factions, all free to hold true to their individual beliefs and policies, no one has to compromise, no one has to give up their identities or the image or brand name of their original organisations. Though **Freedom Alliance** must be the only Federal political party under which name/banner we must all operate, and through which we must all campaign, the candidates put forth by **Freedom Alliance**, consisting of the men and women who would have otherwise campaigned as candidates for their former parties/organisations, being free to hold true to their own policies and ideas, together as one we all must agree to focus our campaign on the core issues as listed below:

1. **Uphold the Constitution** – All the top experts on our constitution agree that the Queen has no real power over Australia. We are for all intents and purposes completely sovereign and independent as a nation. The people have voted time and again to keep our Constitutional Monarchy system, in which the Queen is little more than a symbol; it is the system of checks and balances that is most important, to keep the power vested in the hands of the Australian people, who collectively are the Sovereign of Australia.

The trouble lies not in our Constitution, it is that we have an unaccountable government that for too long has trampled on our highest law, and because the Constitution has not been upheld, our rights and freedoms have been stripped away. There is a belief by some that our Constitution is not in effect due to the Australia Act and other legislation, but this is not true, it is misinformation. Unless the people through referendum decide to remove/change all or part of our constitution, it remains in full effect, ever single word of it as written in 1901, and where it has been amended by referendum.

It should be a priority of **Freedom Alliance** to ensure that all provisions of our Constitution are being upheld, and where the government has acted against or outside of the Constitution, we must boldly and vocally expose this criminality, even calling for Grand Jury indictments and immediate removal of any politician who has acted against the Constitution (which is a good portion of them).

2. **Uphold the Bill of Rights, Magna Carta and Common Law** – As the British Bill of Rights (1689), Magna Carta (1215), and British Common law was the basis of law operating within the states before federation, the Constitution upholds the continuance of these laws, as alluded to in section 108. Moreover, technically speaking we Australian's are British subjects, and therefore still enjoy the provisions of British Common Law. These laws were reaffirmed in the 1922 Imperial Acts application Act, and the Bill of Rights continues to be cited in legal proceedings throughout the Commonwealth realms.

Our rights and freedoms protected under these laws are, just like our constitution, being trampled on not only by the government, but also by the judiciary, which has not been upholding justice, particularly when it comes to government ministers committing treason

and other offences against the Constitution. **Freedom Alliance** must stand firm and contend against all who would strip away our rights and freedoms, and make a mockery of justice.

3. **Restore freedom and liberty** – Freedom is everything. Provided an individual does not harm another person or their property, or infringe upon their rights, we should be free to live our lives as we so desire, without government interference and without restriction. **Freedom Alliance** must put an end to big brother government over-regulation, and put back in place the boundaries and limitations that prevent government interference with our personal lives, and that of the free market.
4. **Restore private property rights** – Through the government unlawfully signing foreign treaties, and implementing foreign agendas and dictates against the will of the people such as U.N. Agenda 21 (which is treasonous), private property ownership is being removed by fiat, by stealth, as tyrannical legislation now restricts many property owners from utilising their land in a reasonable manner as they so wish.

Freedom Alliance will abolish all laws and legislation that place restrictions on private property use. We will take the approach of “education”, rather than “legislation”, to encourage the sustainable and environmentally friendly use of land. **Freedom Alliance** stands by farmers and will ensure they are free to utilise their properties as they see fit.

5. **Restore openness and accountability to Governance** – Never have we seen such criminality and deceitfulness in our Government. It is time the Liberal /Labor duopoly come to an end, and we restore power to the people. **Freedom Alliance** will be a true representative of the people's will, and shall be wholly open, honest and accountable to the electorate.

We shall expose all government lies and deception, and bring to account in a very public manner all who have engaged in treasonous acts, and who have acted against the constitution and against the will of the people. In this cause, we demand the immediately removal of Julia Gillard as Prime Minister, and shall campaign to see justice upheld as the charges of treason against her (and many other politicians, bureaucrats and magistrates as brought before the courts in 2007 by Brian Shaw) are allowed to progress through the courts in an open, public and accountable fashion, whereby a jury of her peers (not a judge) shall determine guilt or innocence.

6. **Uphold the sovereignty and independence of Australia** – In an overzealous drive to break down the barriers between nation states, and to achieve global cooperation and interdependence, our government, like most governments around the world, have been selling out the sovereignty and independent nature of Australia as a free country, and are now implementing laws and legislation which affect us all, that have been determined not by the Australian people, but have been thrust upon us by globalist organisations such as the U.N.

Freedom Alliance stands firm against any attempts whether overt or covert to destroy the sovereignty and independence of Australia, and will expose and bring to account any politician, bureaucrat, business person, media personality, academic or any other persons who have worked seditiously and treacherously against the interests of the Australian people, against the constitution, to destroy our character and to surrender our right to govern for ourselves.

7. **Bring back the use of public referenda** – As the Australian people are collectively Sovereign, and the will of the people is above the parliament, **Freedom Alliance** will return power to the people by supporting the use of the public referendum to decide on important policy decisions that affect the Australian people. We also support and encourage the use of citizens initiated referenda; within reason, the government should facilitate the carrying out of such citizens initiated referenda (where it can be shown there is reasonable community support behind the particular issue or matter).

As a matter of priority, **Freedom Alliance** will initiate a public referendum on the controversial matter of public water fluoridation, and allow an open debate on the pros and the increasing cons of the use of Fluoride, a chemical that is sourced from the toxic waste bi-products from Aluminium and fertiliser production. Referenda will also be held to allow the public to decide upon any other issues of contention that potentially affect peoples health such as the use of GMO foods, and weather modification techniques being employed by many governments around the globe.

8. **No emissions trading scheme or carbon tax** – We acknowledge that climate change occurs; it's an undeniable, scientifically proven fact. We are, however, against the propaganda emitted by the corporate mainstream media and government bodies abroad, that proliferate the theory that “global warming” is anthropogenic (caused by the emission CO2 gasses) all for the purposes of establishing yet another tax and mechanism for the international bankers to rob us all, and de industrialise the west.

Freedom Alliance will however fight to protect the environment from real threats such as the spread of genetically modified organisms (plant and animal), the real toxic and chemical pollution of our air and waterways (CO2 is not pollution, but one of the elements essential to life), and other genuine threats to the environment, and to the health of humanity.

Apart from these core policy positions that **Freedom Alliance** candidates can all agree upon, candidates are free to hold to the policies and views of their organisation, or as their heart so leads them. It shall be agreed upon that anything outside of the core policies shall not become a matter of contention or division between us, because they must be secondary to the core principles that the **Freedom Alliance** is built upon.

Beyond these policies, we all shall, in a spirit of unity, peace, understanding and acceptance, discuss and debate with one another in open forums upon any other policy we as individuals / organisations within **Freedom Alliance** may want included along with the core policies. As an example, we could all offer up to one another any reasoning, evidence and or detailed plans and make a presentation to one another as to what position **Freedom Alliance** should take in respect to taxation.

If we cannot come to a consensus, then we as aligned organisations can maintain our separate policies, ideas and philosophies, but simply place them on the back burner as we continue to jointly campaign on the core policies... which should be enough as they are directed towards the essence of truth, freedom and justice upon which we can all agree. Working together on these core issues should cover the central purposes upon which all our organisations have been established. Better to work together and have success on these most important points, then to remain divided and have no success at all against a government that will do all it can to keep us divided.

So the beauty of **Freedom Alliance**, apart from the incredible power and blessed spirit of unity, is that we can all maintain our separate identities, hold true to our beliefs, and not compromise upon

any issue that you or your party/organisation may be passionate about. On a practical level, to ensure that all groups can preserve their separate identities, the **Freedom Alliance** website will prominently list and link to all websites of the separate organisations that comprise this new, powerful federal political party.

When any person becomes a member of **Freedom Alliance**, they will have the option of ticking a box to clarify which faction within Freedom Alliance they most support, or they may tick none at all. A membership database will be kept whereby it will be clear which faction within Freedom Alliance has the most support, but this will not have any consequential effect upon how the Alliance is to operate, apart from making a determination upon the possible distribution of a small portion of the total funds received from the AEC, after the candidates/ parties have been refunded for any personal funds they contribute towards the campaigns of their candidates, and after monies have been put aside for future **Freedom Alliance** national campaign advertising.

The leadership of **Freedom Alliance** will be comprised of a committee, where each organisation/ party represented within Freedom Alliance shall have one representative on the committee, all with an equal vote despite the size or number belonging to their particular faction. The position of President, vice-president, Secretary and treasurer should ideally be committee members who are able to in essence divorce themselves from their organisations goals, and commit to being unbiased facilitators of Freedom Alliance. If this cannot be done, I suggest we allow these positions to be filled by people who are altogether unaligned with any of the organisations, but who support the mission of **Freedom Alliance**.

I am already under way to registering a new incorporated association, with rules that will allow for **Freedom Alliance** to function smoothly being a coalition of organisations. The leadership/ committee, any person operating in any capacity within **Freedom Alliance**, and any candidate running under the name of the party must be signed members of the association, agreeing to abide by the rules and conduct of behaviour. The great majority of members who sign up to **Freedom Alliance** do not have to sign up to the Association, but can simply sign up as ordinary members of the Federal political party.

I will ensure the association rules maintain unity of purpose, and also help prevent any possible infiltration or co-opting of Freedom Alliance by any seditious persons (possibly working for the government) that may attempt to diminish what Freedom Alliance will become.

To ensure **Freedom Alliance** is registered as a federal political party as soon as possible (hopefully in time to contest the upcoming election – we must move quickly), I would call upon all of the associated political parties to agree that we should use the current federal registration of which ever party has the most members, and that they should promptly have a name change approved by the AEC. This is only for technical purposes, as which ever federal party undergoes the name change must completely agree to open up to being administered as per the Freedom Alliance Association I referred to, whereby each organisation has one of their members represented on the committee.

The same party that undergoes the name change will also undergo a policy change in accordance with the policies outlined above. Once this is accomplished, all current members of every other “federal” party will de-register and become signed members of the new **Freedom Alliance Party**. Each political party can, as it seems appropriate for the time being, continue to maintain their registration as state based parties, but on the federal level, we all come under the one name of **Freedom Alliance**.

Remember, we are all giving up (even the party doing the name change) our separate “federal” registration in order to accomplish this, but do not let your hearts be concerned, as you will all now be a part of what could be Australia's biggest and most promising political party, a party that can and will rival the superpower known as the Labor/Liberal cartel. If we get this right, if we follow this plan, this may just be our chance at saving this nation, for if we miss this opportunity to unite, we all fail, and we have failed our children and our children's children.

What I am about to say may be the hardest pill to swallow, but if we are in agreement, it will not have any tangible practical downsides. In the event that the name change (being published by the AEC in the Gazette for one month) is not confirmed in time for this upcoming federal election (before the writs are issued), we should still go forth with the **Freedom Alliance** plan except for the one alteration being that we will run under the former name of which ever party is doing the name change. However, with a media campaign expressing the coming together of all these different groups, uniting together in support of the core policies, it really matters not what name we run under, so long as we all have unity of purpose. After the election, the name will then of cause convert to **Freedom Alliance!**

Beyond the incredible possibilities that open up to us as a united and powerful force, I will detail some plans, some initiatives that we can work on beyond the election. Even if **Freedom Alliance** fails to place even one of our candidates into the Federal Senate and or House of Reps, there is still so much we can do working together. First and foremost, we should all get behind a campaign to have a real Governor General appointed.

For those of you who may not know, according to the constitution, the Queen is supposed to appoint the Governor General, and she does so only upon the petitioning of the Australian people. For over 40 years, we have not had a legitimate GG, as the Prime Minister has been appointing a GG (the Queens representative). We can, working together, organise a petition to the Queen (a mandate from the people) to appoint a Governor General whom we choose (and she must do as we wish), and there are several candidates I know who are up for this, men of integrity who have proven themselves to tirelessly campaign to uphold the Constitution. A real GG who works for we the people has the power to sack any politician and any government that is not acting in accordance with the Constitution.

Do not underestimate just how powerful an initiative this is. Even if we cannot wrestle Canberra out of the hands of these criminals, at the very least we can and will have OUR GG appointed by the Queen, and this will go a very long way to restoring freedom and justice, all that is needed is for what we already have in the Constitution to be enforced, to be upheld. This should be a priority of the Freedom Alliance, after this upcoming election.

Another initiative I believe there is incredible scope to work on together, is for us to establish our own community bank/credit union/ superannuation fund. Imagine for one moment, if **Freedom Alliance**, having over 50,000 members, were to have our members transfer their superannuation into our own “Freedom Bank/super fund”, particularly as no one has any real motivation to keep it where it currently is since most funds are losing peoples money, then we are talking a potential \$2.5 billion invested into a fund that the Freedom Alliance committee will have some guidance over where the money is invested.

Now, we would organise it so that at least 50% of all money invested into this Freedom Bank would go straight into precious metals (gold and silver), so that no matter what happens with the world economy (looking more likely to completely collapse very soon), at least half of our members

superannuation will be secured by gold and silver (the price of which continues to sky-rocket), whereas everyone else will simply have their super vanish into thin air.

The other half could be invested into local businesses and projects that help to promote our ideals of community, sovereignty, good (natural) health, proper education and so forth. Imagine, Australia's only honest bank, owned by Australians, working for Australians, and it will be known Australia wide that it was a Freedom Alliance initiative. The publicity this will generate for us is worth it just on its own, let alone the fact that a very small percentage (of several billion, lol) of the profits could be paid back into the Freedom Alliance Association... of course absolutely not to line our pockets unlike the other banks, but to plough back into our campaign to save this country, although it could go some way to paying salaries for people working full time for Freedom Alliance.

Since we do not receive the crooked funding from the corporations that the Liberal/Labor cartel receives, we will have our own source of funding for our future Freedom Alliance campaigns, and we will become a force to be reckoned with. Such is the vision I have for Freedom Alliance, a vision that can only be accomplished if we all work together. The ultimate vision is for us to take government, and make Australia the most free, just, and prosperous nation in the world.

With your blessing, I pledge to offer up myself as an unbiased facilitator to make **Freedom Alliance** a reality. I will work tirelessly for all of us, but this not a job for one man. I already have in principle support from most of you, what I need now is any final submissions you may want to make in regards to the core policies, although they are open to change later on as we begin to sit down with one another. The Australian Sovereignty Party and the Climate Sceptics party are positively confirmed in this merger (and I have support from Aussie speeding fines with over 12,500 members), I need the rest of you to move quickly in response to this initiative, this is the only way way can save Australia, and you all know it!
